30 %-ruling

The 30%-ruling is a special expat ruling to get special expertise to the Dutch market. For you it will mean that 30% of your gross salary is tax free to cover your extra territorial costs. In addition you will –upon request – be treated as a non tax resident for your box 2 and 3 income. This means that you are not taxable for dividends from non-Dutch companies and your world wide assets, with the exception of Dutch real estate. Finally you will be able to exchange your non-EU driving license without having to take a new test.

It is of utmost importance to be properly advised before you take any action to qualify for the 30% ruling. It is essential to come from abroad at the request of your new employer. Again Suurmond Tax consultants will be able to give you tailored advice to have the 30% ruling granted to you. Promovendi qualify more quickly for the 30%-ruling. Again, getting good advice beforehand is essential. To qualify for the 30% ruling you need to be recruited from abroad. Suurmond Tax consultants will be able to advise you on how to qualify. You will see your income going up like a rocket if your circumstances are tailored by J.C. Suurmond & zn Tax consultants.

With effect from 2027, the maximum tax-free allowance will be 27% instead of 30%. The 30% ruling is also capped to a certain income level called the WNT norm (also known as the Balkenende norm). In 2025 this amount is € 246.000 on an annual basis. This means that the 30% will not be applied to the part of the income that exceeds this amount. Furthermore, as mentioned previously, it is no longer possible to opt for partial non-domestic taxation from 2025 onwards.

Tax Domicile

Your tax domicile is not always clear as it depends on a number of factors. If you work in The Netherlands during the week and go back home at the weekend and for holidays your tax domicile is most likely not in The Netherlands.

Contact one of our advisors to investigate where your tax domicile is and if your income is entirely, partly or not taxable in The Netherlands. Get advice before you take on a new job, buy property or register with the council. This could save significant amounts of money.

Salary split

It often proves very worthwhile to split your taxable salary between two or more countries. This is sometimes possible if you are resident in one country and work in one or more other countries.
